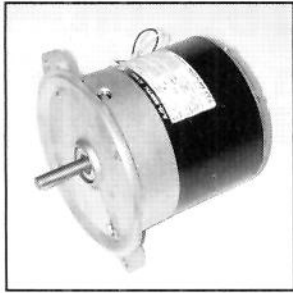

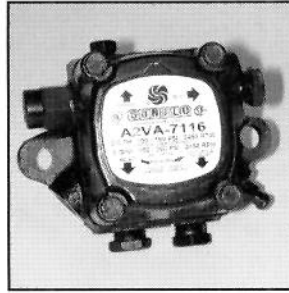

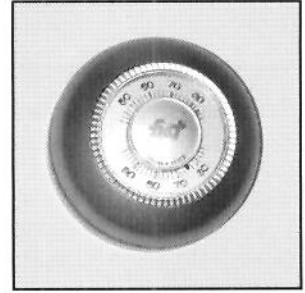
Burner Motor



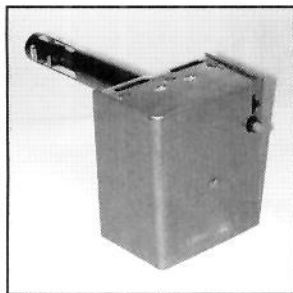

General Conditions

1. The Service Plan is intended to complement the supplying of heating oil to Laurel Fuel Oil customers. Laurel Fuel Oil reserves the right to decline to accept coverage of equipment under this Service Plan after inspection of the burner and equipment.

2. Acceptance by Laurel Fuel Oil of this Service Plan does not obligate us for consequential or secondary damages or loss caused by leakage from customer's oil tank or oil lines, malfunction or failure of equipment or other conditions resulting from delays or failure to render service or for damage resulting to unoccupied buildings. Laurel Fuel Oil shall be liable only for loss, damage or injury attributed directly and solely to its negligence. Repairs authorized by customer, involving labor or parts not covered under this plan, will be billed at Laurel Fuel Oil established rates.

3. This Plan does not include the cost of labor or materials for repairs or replacements required because of Acts of God, fire, water, boiler failure; or defects in radiation, piping system, duct work, air filters, humidifier, automatic water feeders, low water cut-offs, water circulators, blowers & blower motors, domestic hot water equipment or system accessories.

4. This Service Plan includes only repair and replacement by Laurel Fuel Oil of parts specifically listed in the plan which are defective due to ordinary wear. The obligation of Laurel Fuel Oil to repair or replace parts is subject to the availability of such parts from its normal sources of supply.

5. This Service Plan covers one oil burner only and service thereto for a period of one year from the date Laurel Fuel Oil accepts this Plan, and will continue from year to year thereafter at Laurel Fuel Oil then prevailing rates. It may be terminated by either party at anytime upon 30 days written notice.

6. Customer will be charged at Laurel Fuel Oil established rates for service calls resulting from: lack of oil, when customer does not use our automatic delivery service, failure of customer to maintain proper water level in boiler, improper settings of the thermostat, or emergency switch "off."
